proposal for deployment of ACTOs to checkgates and I.P, the JCCTs should submit the service records (details of posting) during the last five years and should also certify that the ACTO is competent, courageous and their integrity is beyond doubt and no ACTO should be deployed by the JCCT to any checkgate and I.P for more than three months.
