The Axis Bank Ltd. Arch' Bishop House, Satyanagar Bhubaneswar-751007, District-Khurda designated as the e-Focal Point Branch of the concerned Bank shall collect Commercial Taxes/dues of the Government of Odisha in e-mode with the condition that the existing system for reporting of State Government transactions to Reserve Bank of India will be kept unchanged. Further the bank shall be guided by the instructions contained in the "Memorandum of Instructions-Accounting and Reconciliation-State Government Transactions" and other instructions issued by the Reserve Bank of India from time to time in the matter.

The accounting, reporting and reconciliation of e-Receipt of State Government taxes and dues through Cyber Treasury shall be made as per the procedure outlined in F.D. Resolution No.3571/F dated 31.1.2011. However, all other existing procedures for submission of accounts to A.G. (A&E), Odisha as well as reporting to the RBI will remain unchanged.

This will take immediate effect.
